SUBJECT: REGARDING CORRECTION IN THE DETAILS OF ONLINE APPLICATIONS FILLED UP BY THE CANDIDATES WHILE APPLYING FOR BHMS (CET CODE 154) PROGRAMME FOR THE ACADEMIC SESSION 2019-20.

In continuation of earlier University notification under above reference and in continuation of Important Instruction given in Part-A of Admission Brochure 2019-20 at point 9 of para 1.9 (page 11) whereby it is mentioned that "After the application for any CET is submitted, if there is any mistake in date of birth, spelling mistake in name of applicants or the parents name or in the choice of category/region claimed for the purpose of availing reservation, the applicant must submit an application in physical form (together with applicable processing fees of Rs. 500/-) to: Reception, Examination Division, Guru Gobind Singh Indraprastha University, Delhi".

The University vide notifications dated 13.06.2019 and 17.06.2019 under above reference has already given opportunity for removal of discrepancies/mistakes in the application form filled up by the candidates while applying for BHMS (CET CODE 154) programme for the academic session 2019-20. However, all such candidates with specific reference to the BHMS (CET CODE 154) programme only for the academic session 2019-20 are given an opportunity to remove their discrepancies observed/found in their application forms filled online for BHMS (CET CODE 154) programme.

Based on the record available with the University, the following two lists of the Registered applicants for BHMS (CET CODE 154) programme are attached herewith for information and necessary action (wherever required) of the concerned candidates:

The candidates are requested to go through the above stated lists carefully and note the details mentioned therein, if any correction/discrepancy is observed as stated above or otherwise like NEET Roll Numbers etc., are advised to see their names in the respective list, and if any; discrepancy is observed, then they have to submit the request application in physical form along with copy of fee challan of Rs. 500/- submitted in Indian Bank Branch at GGSIP University, Dwarka, Sector 16C, New Delhi. The candidate must submit the application along with relevant document in support of removal of discrepancies and challan of Rs. 500/- at the Enquiry Window of the Admissions Branch, GGSIP University, Sector 16C, Dwarka, New Delhi - 110078 on working days on 08.07.2019 to 09.07.2019 between 11:00 a.m. to 04:30 p.m. However, no payment is required in case of change of existing category to EWS category. No request for removal of discrepancies through email shall be entertained.

All concerned may please note that this is an opportunity given to the candidates for removal of their discrepancies in their details so filled in their application form. No such opportunity will be given after the above referred date and time.

The candidates are also informed that the counselling for BHMS (CET CODE 154) admissions is likely to conducted Offline instead of Online within the University campus, for which a formal notice shall be displayed on the University website after approval of the Competent Authority.
