CANDIDATES HAVE BEEN CALLED TO ENSURE THAT THE SEATS ARE FILLED UP. HOWEVER, THE\_COUNSELLING FOR THE SEATS RESERVED FOR ANY REGION / CATEGORY SHALLO BE STOPPED AS AND WHEN THE SEATS IN / OF SUCH CATEGORY / REGION ARE FILLED UP.

ADMISSIONS IN PROGRAMMES BASLP AT ALI YAVAR JUNG NATIONAL INSTITUTE FOR THE HEARING HANDICAPPED AND B.SC. MLT AT VARDHMAN MAHAVIR MEDICAL COLLEGE & SAFDARJUNG HOSPITAL, WILL BE DONE ON ALL INDIA BASIS IN THE ORDER OF MERIT. FURTHER, OBC SEATS ARE AVAILABLE IN GOVT. INSTITUTES ONLY.

FOR OBC CERTIFICATE: The non-creamy layer certificate should be issued after 31<sup>st</sup> March, 2019. However for Central Government Institutions, seat allocation is on all India basis among the category of seats including OBC and for such reservation the certificate issued should as per the central list of OBC and the non creamy layer certificate should be issued after 31<sup>st</sup> March, 2019.

2. <u>SANCTIONED INTAKE/SEAT MATRIX</u>: The category wise seats to be filled up by the GGSIP University, shall be displayed before the start of the counselling.

3. <u>ELIGIBILITY CRITERIA FOR PARAMEDICAL PROGRAMMES UNDER CET CODE-</u> 124:

Pass in 12th Class of 10+2 of CBSE or equivalent with a minimum aggregate of 50% marks in Physics, Chemistry and Biology provided the candidate has passed in each subject separately. A candidate also must have passed in English (core or elective or functional) as a subject of study in the qualifying examination.

- 4. FEES TO BE PAID AT THE TIME OF COUNSELLING/ALLOTMENT OF SEAT in the University, a candidate will mandatorily bring a Demand Draft of Rs. 16000/- (Rs. 15,000/- + Rs. 1,000 non-refundable counselling participation fee) in the name of REGISTRAR, GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY, payable at DELHI. Balance fees, if any, shall be paid by the candidate directly in the respective allotted college.
- 5. DATE AND TIME OF WITHDRAWAL OF ADMISSION: The allotted candidates may withdraw their admission upto 05.00 PM on 25.10.2019. Such candidates shall visit the Admissions Branch, GGSIP University, Sector 16C, Dwarka, New Delhi along with their original admission slip along with the prescribed format (Appendix 8 Form for Withdrawal of Admission available in Part B, Admission Brochure 2019-20).

#### Important:

- The counselling will be subject to availability of vacant seats if any and in any category.
- Allotment on the horizontal seats shall be carried out as per the guiding lines given in the following paras.
- A candidate belonging to any sub-category is also eligible to secure admission in General / Unreserved Category of his/her respective Region, purely on the merit of CET.
- The Defence and PWD reservation shall be in all categories in a horizontal manner. If the seats of these sub-categories (i.e. UR-DEF, SC-DEF, ST-DEF, UR-PWD, SC-PWD & ST-PWD remain vacant, they shall be reverted to the parent category during the 2<sup>nd</sup> Counselling.
- The conversion of seats reserved for SC, ST to General Category shall be done only after the completion of last counselling for the reserved categories and no such conversion will be allowed during the 1st counselling. However, while converting the seats, any unfilled seat(s) reserved for ST Category will be offered to SC Category and vice versa and only after that the conversion of the reserved category seats shall be effected.
- Allotment of Seats will stop as and when the seats get filled up.

## 6. SEAT ALLOCATION IN DELHI AND OUTSIDE DELHI REGION:

### Note:

i. The candidates who have passed the qualifying examination through Distance /Open Education system of any recognized University/Board and fail to provide the proof of his/her study centre being located in Delhi shall not be considered for Delhi region seats, and shall be considered for admission in the Outside Delhi Region.
