**SUBJECT: REGARDING 3<sup>RD</sup> / MOP-UP ROUND OF OFFLINE STATE COUNSELING FOR VERIFICATION OF DOCUMENTS AND ALLOTMENT OF SEATS IN PGAC (MD/MS AYURVEDA) (CET CODE 196) IN CH. BRAHM PRAKASH AYURVED CHARAK SANSTHAN, NEW DELHI (AFFILIATED TO GGSIP UNIVERSITY) FOR THE ACADEMIC SESSION 2019-20.**

With reference to the subject cited above, this is for information of all the concerned/stake holders that as per the Revised Time Schedule for completion of counselling and admission process for first year M.D/M.S. (AYUSH) for the academic session 2019-20, the 3<sup>rd</sup> round/Mop-Up round of State Counselling for admission to MD/MS Ayurveda is to be conducted between 16<sup>th</sup> October to 19<sup>th</sup> October.

However, as per the vacancy status received from CH. BRAHM PRAKASH AYURVED CHARAK SANSTHAN, NEW DELHI, vide communication dated 15.10.2019 (copy attached), there are no seats vacant under State Quota for PG course in CBPACS and there are 03 seats vacant under AIQ for which the counseling is to be conducted by Ministry of AYUSH. Hence, there are no vacant seats for admission to PG course during 3<sup>rd</sup> round / Mop-Up round of State Counselling for PGAC and no 3<sup>rd</sup> round (Mop-Up round) shall be conducted by the University due to non-availability of vacant seats in PGAC under State Quota.

However, as per the Revised Time Schedule for completion of counselling and admission process for first year M.D/M.S. (AYUSH) for the academic session 2019-20, the University shall conduct Offline State counselling for admission to PGAC (MD/MS Ayurveda) on or after 25<sup>th</sup> October, 2019 after transfer of Non-Reporting & Non-Joining Vacant Seats of AIQG, AIQGA, AIQP, if any, to State Quota including the seats that may fall vacant in CBPACS for which a notice shall be displayed for information of all the concerned on the University website.
