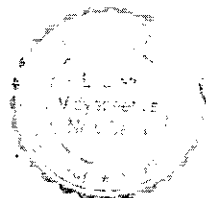

All the aspiring candidates are hereby informed that after the 1st Counselling of the Management Category Admissions held on 11.08.2019, the following is the vacancy status:-

On account of the delay in the admission process, it has been observed that the overall response of the aspiring candidates for admission in the Management Category is very poor and only limited number of candidates have applied and reported for admission. Further, no candidate of any of the Reserved Categories (SC/ST/Def./PwD) has applied or reported till 1st Counselling. In view of this and considering the larger interest of the aspiring candidates, such candidates of Reserved Categories (SC/ST/Def./PwD) and also of General Category, who are still desirous of taking admission in the Management Category and could not apply by the last date and are under "NOT ADMITTED" Category, can directly report on 14.08.2019 upto 09:00 a.m. along with all the required documents and applicable fee (in form of DD/Cheque) for admission against the vacant seats (if any) in the Management Category during 2nd Counselling. Merit List of such candidates having reported directly during 2nd Counselling shall be prepared at 10:00 a.m. on 14.08.2019. However, their candidature shall be considered for admission in the Management Category during 2nd Counselling, only if the Main Merit List displayed on 10.08.2019 and Supplementary Merit List drawn on the basis of the applications received on 11.08.2019 (on the day of 1st Counselling) are exhausted and still the seats remain vacant. Such vacant seats shall be offered to the candidates on Merit based on direct reporting.

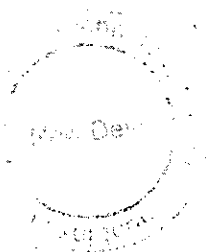


