



Final Opportunity to all Reserved Category Candidates for Verification
Before Conduct of Last Round (With Conversion) for verification through
Online Counselling
(Academic Session 2019-20)

This is for information of all Reserved Category Candidates who had submitted their Counselling Participation Fee and Registration carried out in the Online Counselling within scheduled Date and Time, but did not get their Reserved Category verified before as per notification issued by University from time to time. The University before the process of conducting last Round of Online Counselling with conversion of seats, Last and Final opportunity is being given for such Candidates with Reserved categories to get their Reserved Category verified along with **relevant supporting documents in Original.**

Following are the Reserved Category Candidates who are eligible to verify their Reserved Category:

1. The candidates who have been allotted seat in Round 01 and paid the Part Academic Fees of Rs.40,000/- and are in Participation in Last Round (Without Conversion)
2. The candidates who have submitted Counselling Participation fee, Registered and filled choice, but not allotted seat in any Round of Online Counselling.

Following are the Reserved Category Candidates who are not eligible:

1. The candidates who have been allotted seat in Round 01, but did not pay Part Academic Fees of Rs.40,000/- within stipulated date and time and is not in Participation in the Last Round (without conversion)

All such Candidates who have to get their Reserved categories verified have to submit a challan of Rs.500/- in the Accounts Branch, GGSIP University from 9.45 AM to 10.50 AM on 01.08.2019 and submit at Reception Counter of Admission Branch, Administrative Block, GGSIP University with Challan of Rs.500/- upto 11.00 AM on 01.08.2019.




