### A. Terms and Conditions for New Entrants

I undertake that if a seat according to my choices / preferences of Institution / programme is allocated to me then I shall deposit additional Rs. 1000/- as participation fee for Spot Counselling and total fee payable including part academic fee of Rs. 40,000/- for Institute / programme

### B. Those who were in Online Counselling system and have been allocated a seat and have also reported as admitted.

- (i). I undertake that if a seat in Spot Counselling according to my choices / preferences of Institution / programme is allocated to me then I shall deposit additional Rs.2000/- as participation fee for Spot Counselling and Balance fee payable at the new Institute / College will be deposit by me.
