## NOTICE FOR AFFILIATION PROCEESING FEE FOR THE ACADEMIC YEAR 2019-20

In continuation to the notice no. GGSIPU/Incharge(Aff.)/Misc./2019-20/2787 & GGSIPU/Incharge(Aff.)/Misc./2019-20/2788 dated 25.03.2019, all desirous institutions (existing / new) are hereby informed that the affiliation processing fee for grant / continuation of provisional affiliation for the academic year 2019-20 is as under:-

## A. Affiliation processing fee structure for the existing institutions:

S. No.	Particular	<b>Processing Fees</b>	Application Fees for new / additional programme
1.	Institute located in Delhi	Rs. 45,000/- per programme	Rs. 10,000/- per programme
2.	Institute located Outside Delhi	Rs. 30,000/- per programme	Rs. 10,000/- per programme

However, Institutions established and run by Central Govt., the Govt. or a State Govt., or fully funded by the Central Government/ State Govt. / PSU/Corporation etc. /Societies enacted by Act of Parliament, etc. under the direct administrative control of Central Govt./State Govt., are exempted from submitting any fee.

## B. Fee for the new institutions:

For the new institutions an amount of Rs. 10,000/- per programme.

The above fees would be deposited in the Indian Bank, GGSIP University Branch through Demand Draft after taking permission from the Affiliation Branch. The details of the deposition of fees will have to be entered in the online application form.

For deposition of the processing fee for continuation of existing programmes and new programmes, a written request has to be submitted in the Affiliation Branch for approval. After taking approval from affiliation branch copy of request letter has to be deposited in the Indian Bank, GGSIP University, Sector 16-C, Dwarka, New Delhi – 1:0078 along with the Demand Draft within working hours of Bank 10.30 a.m. to 3.30 p.m. (2.00 pm to 2.30 p.m. lunch time). University will not be responsible for any delay in deposition of fee or uploading of the details and submission of the same after due time i.e. 08.04.2019 till 11.59 p.m. (for submission of online application form for affiliation) and 10.04.2019 till 3.00 p.m. (for submission of printout of online application form for affiliation in Affiliation Branch, room no. 20, Administrative Block, GGSIP University, Sector 16-C, Dwarka, New Delhi – 110078).

On submission of bank receipt of aforesaid fee, the Affiliation Branch will issue login and password to all new / existing institutions for applying on the website i.e. http://ggsipu.ac.in/ipuaffiliation/Login.aspx
