**IMPORTANT NOTICE : ACADEMIC SESSION 2023-24**

**MANDATORY DISCLOSURE OF PROOF OF STUDY CENTRE TO DETERMINE REGION FOR ALLOTMENT OF SEATS IN RESPECT OF CANDIDATES HAVING PASSED QUALIFYING EXMINATION THROUGH OPEN SCHOOL/ CORRESPONDENCE**

1. It has come to notice that candidates who have **completed their qualifying examination (schooling/ graduation) from Open School/ Correspondence** and have also completed online registration on the University portal with the purpose to seek admission in the University Schools or Affiliated Colleges in various programmes have failed to **provide mandatory proof of study centre to determine the region (Delhi/ Outside Delhi), necessary for the allotment of seats.**

2. As per the Chapter-5: Seat Allocation (Except M.Phil and Ph.d.) of the Admission Brochure, the information is reproduced below:

a. 85% seats are reserved for Delhi Region Candidates, i.e. those who have passed the qualifying examination from any School/ Institute located in NCT of Delhi and will be grouped under the "Delhi Region Candidate". These seats will be filled up through the merit/ rank list of the respective CET Code prepared fir Delhi Region candidates. **The candidates who have passed the qualifying examination through Distance/ Open Education system of any recognized University/ Institute and had his/her Study Centres in Delhi will be considered as Delhi Region Candidates but the responsibility to provide proof of his/ her study centre in Delhi will be of the candidate only.**


b. 15% seats are reserved for Outside Delhi Region Candidates, i.e. those who have passed the qualifying examination from any School/ Institute located outside Delhi and will be grouped under term "Outside Delhi Region Candidate". These seats will be filled up through the merit/ rank list of the CET prepared for Outside Delhi Region Candidates. **The candidates who have passed the qualifying examination through Distance/ Open Education system of any recognized University/ Institute and had his/ her Study Centres outside Delhi will be considered as Outside Delhi Region Candidates but the responsibility to provide proof of his/ her study centre outside Delhi will be of the candidate only.**

c. Seat allocation for Delhi Region Candidate and Outside Delhi Region Candidate will be on the basis of directions of Govt. of NCT of Delhi.

3. In case a candidate who has passed qualifying examination (school/ graduation) fails to provide mandatory disclosure of proof of Study Centre, the University shall not be able to determine the region (Delhi/ Outside Delhi) and hence such candidates will not be considered for allotment of seats during Online Counselling.

4. It is for information that the University has already raised observation/ queries on the respective individual portal of such candidates, however, few of them have failed to respond to the observations on individual's portal by not providing the mandatory proof of study centre.

5. In view of the facts brought out above, it is informed that the candidates who have completed their qualifying examination (school/ graduation) from **Open School/ Correspondence** will themselves be responsible for not being considered for allotment of seat during the online counselling if they fail to provide mandatory disclosure of proof of Study centre of the qualifying examination.
