Notice Inviting Proposal for Food Stalls during Anugoonj-2023

Guru Gobind Singh Indraprastha University, Delhi was established in the year 1998 as State University by Government of NCT of Delhi. It is an affiliated cum teaching University and aims to facilitate and promote studies, research and extensions work in emerging areas of higher education with a focus on professional education in disciplines like Engineering & Technology, Architecture, Management, Law, Humanities & Social Sciences, Environmental, Medicine, Physiotherapy, Nursing, Education, Journalism and Mass Communication, etc.

The University is presently conducting around 185 programmes and imparting academic/professional education to around 90,000 students. The main campus is built on 60.46 acres in the picturesque greener of Dwarka, New Delhi.

Guru Gobind Singh Indraprastha University is going to organize its 22nd Annual Cultural Festival 'Anugooj 2023' to be held from 2nd March to 4th March, 2023 on its campus at Sector 16C, Dwarka, New Delhi. Anugoonj one of the largest reputed University festival in Delhi, is an intricate labyrinth of glamour, euphoria and festivities, which attract a major influx of participation from Delhi and outside.

The three-day Annual Cultural Festival 'Anugoonj 2023' will also have star attraction from renowned Bollywood Singer and Rock Band. During the last five years, many stars like Salim Sulaiman, Sukhvinder Sigh, KK, Kailash Kher, Benny Dayal, etc. performed in Anugoonj.

The University invites proposal along with bid from the reputed firms/distributors/authorize dealers for 15 Food Stalls for selling eatable snacks/food items/ beverages during the Anugoonj – 2023 (03 days 2nd to 4th March,2023).

All interested parties may submit their proposal along with bid in the sealed envelope in the O/o Directorate of Students Welfare, GGSIP University, Sector 16 C, Dwarka, New Delhi on 21.02.2023 by 02:30 PM.

Eligibility

- Undertaking by the agency on its Letter head:-
- That it has not been barred or blacklisted by any of the Central/State Government/ Departments/Organizations/Central or State PSU.
- That it will ensure fair trade practice.
- That the proprietor/partners of the agency do not have any relative employed with GGSIP University.
- Should have valid GST Registration.
- Should have valid PAN Card.
- Should have valid Food Safety and standards Licence issued by the Food Safety and Standards Authority of India.

Food Stalls & Facility

 The total number of 15 foods stalls 15 feet x15 feet with 6 tables, 4 chairs, 02 halogen (500–1000W) and 02 power points are available for selling food items/snacks/beverages to the students/ visitors during the Anugoonj 2023.

Criteria for Allotment of Food stalls

- i. There is no price fixed for allotment of 15 stall. In lieu of fixed price, the Vendor will provide the following items free of cost:
 - 700 Refreshment boxes X 3 days (Morning) (Samosa, Frooti, Chips Packet, Muffin)
 - 700 Packed Lunch X 3 days (Dal Makhni, Sahi Paneer, Mix Veg., Rice, 2 Roti, Salad/Raita, Sweet)
 - 700 Refreshment boxes X 3 days (Evening) (Samosa, Frooti, Chips Packet, Muffin)
 - 200 Packed Dinner X 3 days (Dal Makhni, Sahi Paneer, Mix Veg., Rice, 2 Roti, Salad/Raita, Sweet)
 - 600 Water Bottles X 3 days (250 ml Bisleri)
- Quoted price for each food stall in addition to condition mentioned at (i). ii.
- EMD: Rs.50,000/- (Refundable) in the form of a demand draft payable in favour iii. of Registrar, Guru Gobind Singh Indraprastha University, Delhi

Other Terms & Conditions

- Outsourcing/subletting of the food stalls will not be allowed.
- Vendors are required to follow single use plastic free norms. ii.
- Vendors are required to put big size dustbin along with their allotted stall. iii.
- iv. All eatable items should be clean and hygienic.
- The successful firm will sell beverages items Tea, coffee, eatable snacks, food ٧. items, ice cream at designated food stall.
- Alcoholic and tobacco items are not permissible to sale at food stalls. vi.
- The University may discontinue the sale of any items at the food stalls at his vii. discretion without assigning any reason.
- The eligible firm shall ensure that eatable items sold/ served form the food stall viii. are of requisite, hygiene and quality standards.
- The rates of food items should be at par with the normal market rates and ix. rate list should also be displayed near the food stall. The size of font in rate list should be 3 inches. The food items shall not be sold over and above the printed MRP.
- The University officials may at any time monitor the quality of raw material, food X. items and its preparation conditions.
- The eligible firm will be responsible for cleaning of surroundings xi.
- The firm shall be solely liable for any action or penalty imposed by relevant xii. authority. Payment of all applicable taxes including income tax, GST and other applicable taxes will be the responsibility of the eligible firm.
- The University reserves the right to accept or reject any bid without assigning any xiii. reason thereof.
- No firm shall do or undertake any activity contrary to law, public order or health. xiv.
- In case of any dispute relating to sponsorship during the Anugoonj, the decision XV. of the Director, Students' Welfare shall be final and binding for all.
