Brief on Venture Capital Fund for Scheduled Castes (VCF-SC) and Ambedkar Social Innovation Incubation Mission (ASIIM) under VCF-SC.

Government of India through Ministry of Social Justice and Empowerment in order to promote entrepreneurship among the Scheduled Castes) and to provide concessional finance to them has started "Venture Capital Fund for Scheduled Castes (VCF-SC)" in FY 2014-15. Further, the Ministry of Social Justice & Empowerment (MoSJ&E), Government of India in order to boost entrepreneurship and innovation among the SC students / youth (including SC women youths) has launched "Ambedkar Social Innovation Incubation Mission (ASIIM)" under VCF-SC on 30th September 2020. The schemes are operational and applicable throughout the country and are managed by IFCI Venture Capital funds Limited, subsidiary of IFCI Limited (a Government of India Undertaking). The brief of the schemes are as below:

Venture Capital Fund for Scheduled Castes (VCF-SC):

- **Basic Eligibility Criteria:** Companies having at least 51% stake holding by SC entrepreneurs with management control.
- **Investment size in company:** Rs.0.10 Crore to Rs.15.00 Crore. Aggregate assistance not more than two times the current net worth of the company.
- **Returns on Investment:** 8% p.a. for SC Entrepreneurs (7.75% for women/divyang SC entrepreneurs).
- **Invest. Period in Company:** Up to 10 years including moratorium period (i.e. of up to 36 months) on case to case basis.

Ambedkar Social Innovation Incubation Mission (ASIIM) under VCF-SC:

- Basic Eligibility:
 - > Companies having at least 51% stake holding by SC entrepreneurs with management control.
 - > Youth who have been identified by the TBIs. Atal Incubation Centers (AICs), Technology / Industrial Parks, Science and Technology Parks of India (STPI) being promoted by Department of Science & Technology (DST) or other than DST and other incubation centers supported by Government of India.
 - > Youth who are identified for incubation by reputed private TBIs.
 - > Students who have been awarded under the Smart India Hackathon or Smart India Hardware Hackathon being conducted by Ministry of Education.
 - > Innovative ideas focusing on the socio-economic development of the society identified in the TBIs in public, private sector.
 - > Start-ups nominated and supported by corporates through CSR funds.
- **Invest. size in company:** Maximum Rs.30 Lakh in a company, not more than Rs.10 Lakhs in a year.
- Investment Period in a company: Up to 10 years.
