IMPORTANT NOTICE


This is in continuation to Notice No. GGSIPU/DSW/Sports/2023-24/825 dated 25.09.2023 issued by Directorate of Students' Welfare, communicating the guidelines to be observed during the 18th Annual Sports Meet-2023. While supervising all the events, it has been observed that the said guidelines have not be strictly followed by the participating teams .

It is reiterated that the following guidelines must be adhered to without fail:

1. Affiliated Institutes/Colleges Participants

- (a) No request for participants shall be entertained without the Eligibility Performa (Annexure-1). All the teams/athletes will be permitted to participate in 18th Annual Sports Meet of the University **only with proper playing kit.**
- (b) All the teams/participants should report at the venue an hour before scheduled time for the commencement of the tournament/match.
- (c) **All the teams shall have to be accompanied by a Faculty Member Coordinator and a team manager/coach who may be a Physical Education Faculty / Faculty member/ Coach of the college deputed by the Principal/Director.** The name of the Faculty Member Coordinator and a team manager/coach with his/her designation should be entered in the google link <https://forms.gle/oidF1p3f62pj9qXm7> and only such person has the right to perform the duty of the Team Manager. If the team is accompanied by a coach or any other person (other than the Manager), the Principal should authorize person with a letter of authority. No unauthorized persons shall act as the team manager or coach.
- (d) **Under no circumstances a team be allowed to participate in a tournament unless accompanied by a Faculty Member Coordinator and a team manager/coach.**
- (e) The Faculty Member Coordinator and a team manager/coach should submit two copies of eligibility Proforma (Annexure-1) duly filled and signed by the concerned Principal/Director at the venue an hour before scheduled time for the commencement of the tournament/match. All columns of the eligibility certificate have to be filled. No over writing or correction is permitted in the eligibility Proforma.
- (f) The participants should also produce the college identity card duly signed by the Principal/Director at the time of the competition.
- (g) Only permitted number of students/actual participants needs to be entered in the eligibility Proforma.
- (h) If a team withdraws from the championship after giving the entry/drawing the fixture with valid reasons, they should inform the matter to the Directorate of Students' Welfare well in advance.
- (i) Students undergoing disciplinary action in the institute/colleges shall not be allowed to participate in the 18th Annual Sports Meet of the University for the year Academic Year 2023-24.

In addition to above, all Faculty Member Coordinator and a team manager/coach accompanied the concerned team must report to the office of DSW atleast 01 hour before the scheduled time of participation alongwith requisite document.
