Project Saksham 3.O - a **Legal Literacy And Legal Aid Project** - is a collaborative initiative of USLLS-GGSIPU, Law Centre 1, Law Centre 2 of the Faculty of Law - University of Delhi, Jamia Millia Islamia, Jamia Hamdard University, Nek Mission Foundation and Naksh Foundation.

Saksham 3.O is curated with the aim to:

- Uplift & enrich society by focusing on legal aid, education and healthcare. foster equal access to justice and ensure that every voice is heard.
- Support underprivileged individuals by empowering them to exercise their rights.
- Inspire young minds to come forward and contribute meaningfully to society.
- Ensure a safe environment in schools by organizing POCSO training sessions.
- Provide a collaborative platform for lawyers to share documents securely and communicate with needy ones in real -time, facilitating teamwork.

Under the project, **18 underprivileged areas** of Delhi will be covered for providing legal aid and legal literacy in Delhi. (a) Field visits and surveys, (b) mega legal aid camps, (c) Training sessions on POCSO & Cyber Laws (d) Special visits to Rashtrapati Bhavan, Parliament, Supreme Court, High Court, Shelter home, orphanage, old age home, Police stations, Jails, etc. are highlights of Saksham 3.O.

The Project will be implemented in 6 states including the Union Territory of Delhi with Collaboration of 24 universities and several other Government and Non-Govt. organisations. **Bonafede BALL.B and BBA LLB students of the USLLS, GGSIPU can apply for the same.** The posts available are as follows:

1. Student Volunteer
2. Team Coordinator
3. Team Co-coordinator

Students enrolled in the 1st year are eligible to apply for student volunteer only. Students in the 2nd year are eligible to apply for team co-coordinator and volunteer. Students enrolled in 3rd year are eligible to apply for all three posts.

The selected students, on completion of the project will be awarded (i) Participation Certificates and Letter of recommendation (ii) Awards for best performers (iii) Internship opportunities under the legal wings with the prominent advocates of the Supreme Court of India and high courts and so on.
