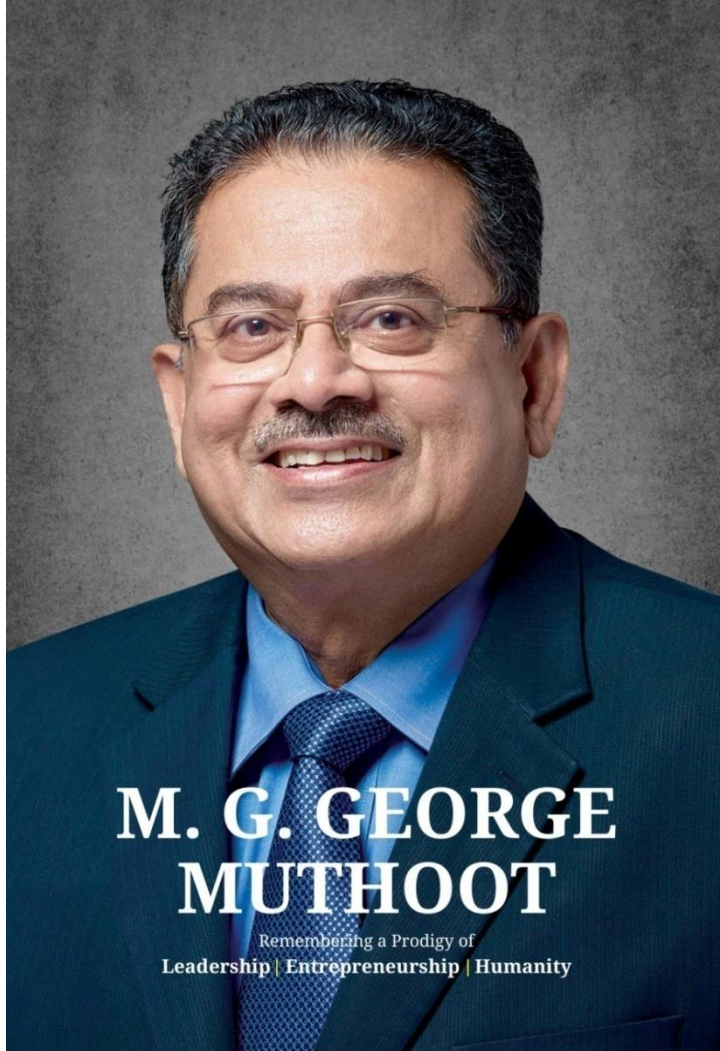

He was also a member of the National Executive Committee of the Federation of Indian Chambers of Commerce and Industry (FICCI) and the Chairman of the FICCI Kerala State Council. Forbes Asia Magazine listed him as the 50th richest man in India in 2011 and his ranking climbed to 44th richest in India according to Forbes' India's Richest list 2019. As per the Forbes' rich list 2020, he was the richest man in Kerala.

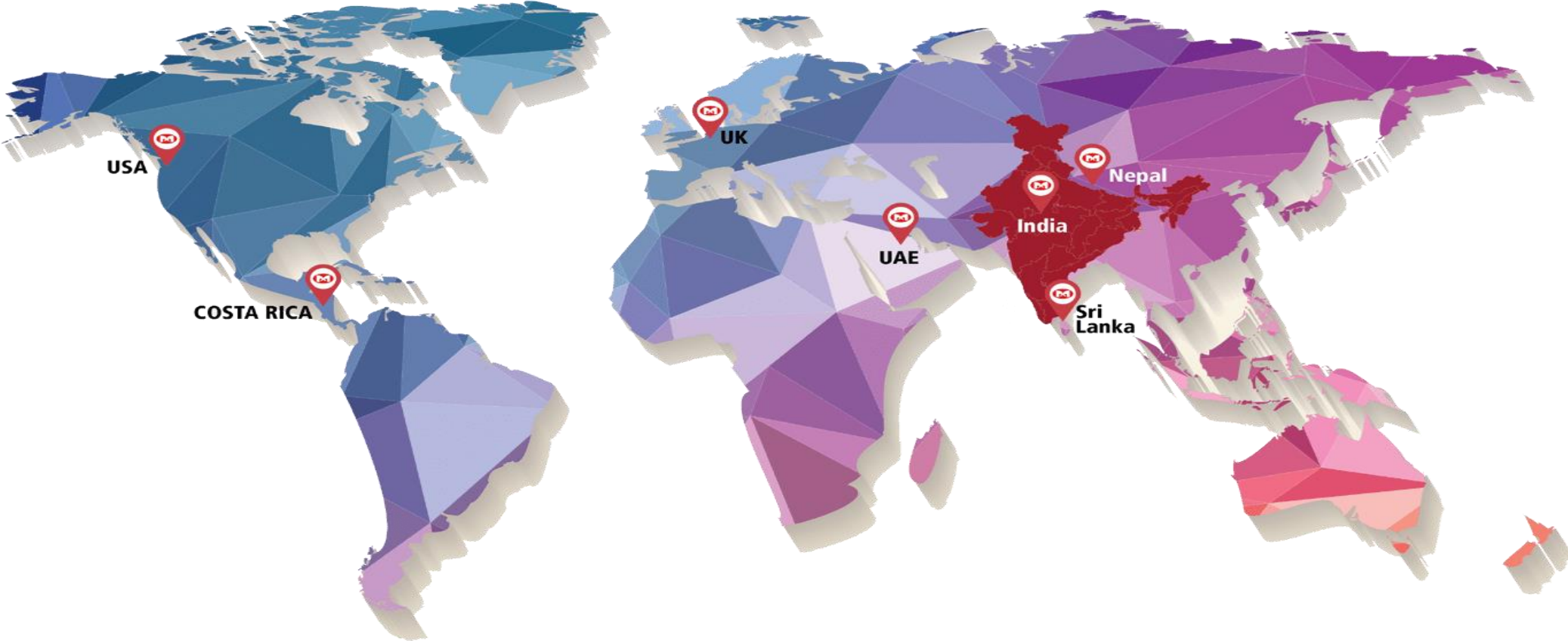

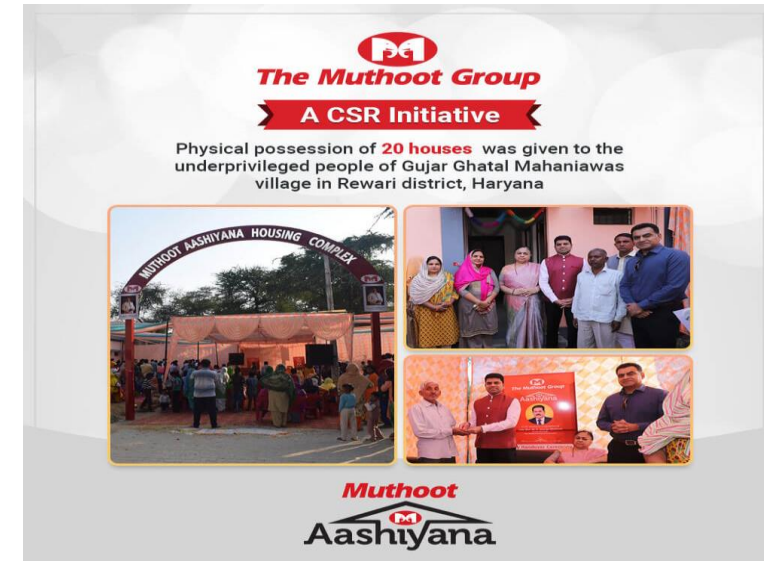


Donation of 100 Winter Tents to Earthquake victims in Turkey where millions have been rendered homeless
