During the Academic Session 2024-25 the University, in addition to the notified National Level test/Common Entrance Tests, shall carry out admissions through the merit of Common University Entrance Test (CUET) (PG) in different programmes.

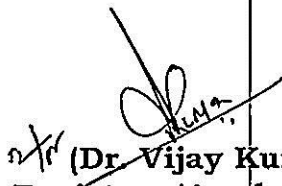
