

- i. **FOR** : Guru Gobind Singh Indraprastha University, Sector-16/C, Dwarka, New Delhi.
- ii. **Delivery:** Within 15 days from the issue of Purchase Order.
- iii. **Delay and Non Conformance** - If the bidder fails to install / supply the item within the period specified in the Purchase Order, University shall without prejudice to its other remedies under the Purchase Order, deduct from the contract price, as liquidated damages, a sum equivalent to 1% (one percent) of the Contract Price of the delayed goods weekly or part thereof of delay until actual delivery. The penalties will be maximum of 10% of the contract amount/ awarded value.
- iv. **Performance Guarantee:** The successful bidder shall be required to furnish a **Performance Guarantee of 5%** after successfully installation of the product at site. Performance Security should remain valid for a period of 60 days beyond contractual obligations including warranty obligations i.e. 60 months comprehensive onsite warranty. The Performance Guarantee shall be accepted in the following form and shall be in favour of "Registrar, GGSIPU", payable at Delhi with a validity of months as under:-
 - i. Fixed deposit receipt (FDR) of a nationalized bank
 - ii. Bank Guarantee
