3. Copy of valid document for Fellowship/ scholarship in UGC-NET /UGC-CSIR NET /GATE and other similar National Level Tests.
4. Valid UGC-NET document mentioning the categories (1/2/3) in accordance with the UGC-NET circular No.F.4-1 (UGC-NET Review Committee)/2024(NET)/140648 dated 27.03.2024 (copy of notice is also attached with this notice for your reference).
5. Copy of Certificate /Marksheet of the qualifying degree. Candidates appearing for final exam of qualifying degree may submit mark sheets upto the penultimate semester.
6. Undertaking that the candidate fulfil the eligibility criteria/conditions as laid down in admission brochure 2025-2026.
