Subject: Constitution of Task Force for the "Safety of Women in the Campus"


Hon'ble Vice-Chancellor has constituted a Task Force for the "Safety of Women in the Campus". The members of the Task Force are as under:

3. The members of the Task Force will suggest remedial measures to Competent Authority to provide facilities and infrastructure to ensure "Safety of Women" in the University Campus.
4. The members of the Task Force will hold the meeting with the stakeholders time to time and invite suggestions for better environment and "Safety of Women".
5. The members of the Task Force will convene at least once in every two months and may also involve the officers of the following committee members:
 - i) Chairman Classrooms committee
 - ii) Members of the Staff Council
 - iii) Members of the Student Council
 - iv) Members of the Staff Grievance Committee
6. The members of the Task Force will attend all the grievances related to women safety and sit together to resolve the issue with immediate action and disciplinary action, any, will be taken as per University rules and regulations by the concerned branch, after approval by the Competent Authority.
7. The members of the Task Force will organize programmes to sensitize the women (staff and students) about their safety by inviting outside agencies.

The Tenure of the committee is for a period of one year.
