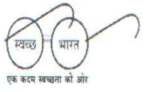

Interim directions of the Hon'ble High Court of Delhi

The Hon'ble High Court of Delhi in various writ petitions filed before it has given interim directions to the University to allow the petitioners to sit for examinations of November – December 2018, as an interim measure. In this regard, some of the petitioners have approached the University. The University has issued admit cards to those petitioners who approached the University by 07:00 P.M. on 28.11.2018.

The University to reduce hardships to those petitioners who have been allowed as an interim measure by the Hon'ble High Court of Delhi to sit for examinations and could not submit their applications to the University for the issuance of admit cards and whose examinations are scheduled on 29.11.2018, may fill attached undertaking and report to the scheduled examination centre atleast half an hour before the commencement of examination. They shall be allowed to sit for the examination only on submission of the said undertaking. After the end of examination on 29.11.2018, these petitioners may visit the University for issuance of admit card by filling-up the appropriate proforma at the University on 29.11.2018.

The petitioners whose examination are scheduled on 30.11.2018 or later, should apply to the University on 29.11.2018 for issuance of admit card, if not already applied for.
