- (4) All mark sheets of previous semesters of current programme**

In case parents are ex-serviceman/ pensioner, enclose the copy of updated bank pass book showing the entry of pension for the last three months.

**The students and their parents, who do not appear for personal interaction, they will forfeit their claim of financial assistance under EWS Scheme. Further, no request for personal appearance before committee will be considered after aforesaid dates.**
